Cooper named CISD chief administrator

Blake Cooper was unanimously named superintendent of Commerce ISD by the Board of Trustees during a special meeting October 27. Cooper will begin his official duties on January 5 but is expected to visit the district several times until then.

Mr. Cooper currently serves as assistant superintendent in Kaufman ISD. He was principal at Edgewood High School for five years and was a teacher and head football coach there for two years before being named principal. At Winnsboro, Garland, Sulphur Springs and Sheldon school districts he has served as a teacher/coach. He was also an instructor/coach at East Texas State University.

After the vote to name him superintendent, Mr. Cooper addressed the Board, administrators and the public saying he was excited about the opportunity to provide leadership to CISD. “There are so many good things going on as evidenced on the district Web site and through Mrs. (Julia) Robinson’s campus presentation tonight, but there is still work to do to get where we want to be,” he said. Addressing staff wearing a Tiger orange tie he said, “I don’t want to be your boss. I want to be your leader. This is not just a one-man show.”

Mr. Cooper was accompanied by his wife Tammy and his daughter Rebekah who will be a freshman at CHS next year. The Cooper’s also have two older sons.

ACW building project on track, on budget

Good weather has contributed significantly to smooth progress at the ACW construction site according to Claycomb Associates Architect Nathan Morgan.

The walls are going up on the classroom wings, parking lots are being finished so that materials can be stored on them and the HVAC system is in initial installation stages. Masonry will begin to go up in a couple of weeks.

Morgan stated that the construction firm of W. B. Kibler was staying on schedule and keeping the site clean. He also explained a significant change of roofing materials which would amount to \$54,000 in savings. The white roof will save energy and make it easier for workers to locate and repairs leaks compared to a conventional tar and gravel roof.

FIRST hearing notes Superior financial rating

CISD maintained its Superior rating by scoring an 80 on the Financial Integrity Rating System of Texas (FIRST). The rating is based on fiscal data from 2006-2007 and State law requires the district hold a public hearing to distribute the report, which it did October 27.

Carrie Alexander, executive director of operations and finance for the district, said factors out of district control such as enrollment and tax collection rate could make a Superior rating harder to achieve in upcoming years.

She explained how students had studied HEROES, the power of one, and had started the year thinking about the characteristics of a hero.

Technology teacher Kelly Cotton showed a production which included highlights of the year thus far, featuring the 15 major events which have been staged. Over 330 parent conferences were held out of 350 students during the first report card pick up. The Fall Carnival, held October 25 at the school, cleared over \$3800 to be used for student field trips.

Robinson said the staff worked to help families and make the school a place that kids love to be.
