## New board member elected

## District to outsource custodial services

The Board unanimously approved a one-year contract with GCA Services Group, Inc. for custodial cleaning services.

Superintendent Blake Cooper said that every current CISD custodian would be hired by the contractor. GCA will provide a full-time manager to act as a liaison between the company and the district. GCA will supply all equipment and cleaning supplies, and will conduct training. A retirement plan and health insurance will be offered to employees.

Cooper recommended GCA based on his experience with them in Kaufman ISD, where he brought them in as the custodial services contractor.

“The company was very complimentary of the shape of our buildings. They commented that we were operating a very lean organization,” Cooper said.

Cost of the service is pennies per square foot more at \$1.40 versus the district’s current \$1.38 per square foot.

Without the contract, the District would be looking at a major expense to replace worn equipment. The custodial services contractor will begin July 1.

## Board approves weight-room equipment purchase

PowerLift was chosen to provide new weight-room equipment for the high school at a cost of \$66,624. Bids were reviewed from four companies.

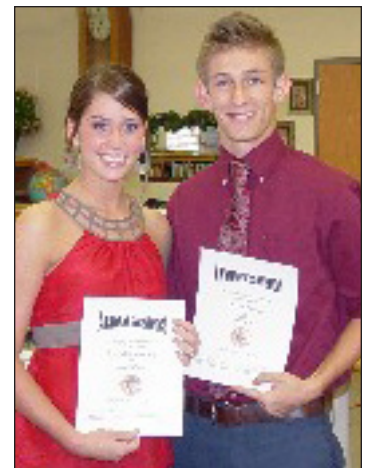
Athletic Director Scott Wells said the PowerLift quality is the highest available and their reputation for service is excellent. Placement and installation are included in the price.

Equipment now at the high school will be used in the middle school program.

## In other action...

The Board approved:

- extension of contract with Guaranty Bond Bank as bank depository for two years
- TASB Policy Update 85 which included policies approving school vehicle use for non-school activities, allowing employees to use the sick leave pool for days lost due to the care of a family member with a catastrophic illness and other revisions due to changes in the federal FMLA, FERPA and ADA laws
- an agreement to add Jay Youngblood as legal counsel and
- dates for 2009-2010 regular school board meetings.

## Board discussion centers on sex offender and drug testing policies

Thoughtful discussion on two controversial issues was undertaken by the Board with several members expressing their personal views.

Last month, Cooper was asked to make sure the District was in compliance with the law on its current sex offender policy which prohibits parents or guardians from attending extracurricular events.

Legal counsel affirmed that policy was in compliance and no challenges have been made to the courts for policies of this nature.

Russell Armstrong said that student safety should be the utmost concern. Willie Blow said he likes to see parents attending events with their kids.

Cooper said last year the district was not following policy by allowing parents to attend events.

Members agreed that enforcement of any policy had challenges but several offered ideas. Cooper was asked to present a policy for approval in June.

Drug testing of students in extracurricular activities was also discussed. Cooper explained that the action serves as a deterrent to drug use. "It would not be a gotcha program. We would build into policy opportunities to get kids help," he said.

Donna Tavener said that since Greenville ISD was set to approve a drug testing policy perhaps we should have policy as well to avoid having students enroll here to avoid the drug testing policy there.

Willie Blow said he has always been against drug testing because "is it teaching what we want to teach?" he said.

Board members asked for more information and sample policies to review.

## Superintendent's report...

Superintendent Cooper reported enrollment at one less than last year — 1593.

Commencement ceremonies have been moved from the Social Sciences Auditorium to the A&M Commerce Field House to allow seating for all who want to attend. Graduates will get six tickets for the reserved seating area. Services will be held at 8 p.m., Friday, June 5.

CHS Principal Virdie Montgomery has been selected to attend the Raise Your Hand Texas Leadership Program at Harvard University this summer. Only 100 principals were selected from 350 candidates. All expenses will be paid by Raise Your Hand Texas.

Summer school will begin June 8 at CES and CMS. Credit recovery as well as classes for advancement such as Health or Communications Applications will be offered. ESL and TAKS tutorials will also be available.

In the Communities In Schools report, case managers Lois Stevens and Matt Wolcott report working with 84 active volunteers in April.

The bid for furnishings for the new A.C. Williams Elementary School came in \$200,000 below the original estimate. Furniture will begin arriving the second week of July and will be assembled and placed by the company.

New school start and stop times were presented.

The new schedules should lessen the waiting time for students in the afternoons. In-town routes will be zoned to take students home directly from each school instead of picking up students at each school before the trip home. Benefits include age appropriate bussing, more instructional time at elementary campuses and all staff is teaching and working the same amount of time.

The Board set Tuesday, June 9 for a special budget study session at 6 p.m. in the Administration Building and the next regular meeting is set for 7 p.m., June 22 at the CMS library.

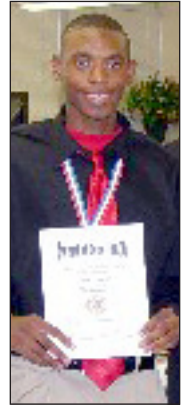
