Minutes of the Regular Meeting

The Board of Trustees Commerce ISD

A regular meeting of the Board of Trustees of the Commerce Independent School District was held on May 20, 2019, at 7:00 p.m. at the Commerce ISD Administration Building, 3315 Washington St., Commerce, Texas. President Kathleen Hooten called the meeting to order, extended a warm welcome and announced that a quorum was present. The meeting had been posted for the time and manner required by law.

Board members present were Mrs. Hooten, Dr. Ray Green, Dr. LaVelle Hendricks, Ms. Etta Herring and Mr. Gabe Wittkopf. Dr. Mark Reid was absent and Mr. Randy Starks joined in executive session.

Executive Session...

Mrs. Hooten announced that the Board would convene in executive session at 6:09 p.m. to discuss personnel (§551.074) and hold a private consultation with the Board's attorney, if necessary (§551.071).

Reconvene from Executive Session...

Mrs. Hooten announced that the Board ended its closed session 7:07 p.m. on May 20, 2019.

Opening Activities

Mr. Starks led an invocation. The pledge to the American flag was led by Dr. Green and the pledge to the Texas flag was led by Mr. Wittkopf.

Reorganization of the Board of Trustees

Dr. Hendricks made a motion to nominate the current officers to remain in their roles— Kathleen Hooten, president; Randy Starks, vice president; and Etta Herring, secretary. Mr. Wittkopf seconded the motion. The motion carried unanimously.

Mr. Wittkopf made a motion to accept the resignation of Kaley Stringfellow, Tri County SSA diagnostician. Mr. Starks seconded the motion. The motion carried with five ayes and one abstention—Dr. Green.

Mr. Wittkopf made a motion to employ Jennifer Kinder, LSSP, and Laurie Meissner, diagnostician, for Tri County SSA. Mr. Starks seconded the motion. The motion carried with five ayes and one abstention—Dr. Green.

Citizens' Comments

Joseph Armstrong from Team North Texas approached the Board about the process for awarding bids for the FACE Center remodeling.

Consent Agenda

Dr. Green made a motion to approve the minutes of the regular meeting on April 15, 2019 and the special meeting of May 7, 2019 and the financial statements and investment summary for April 2019. Ms. Herring seconded the motion. The motion carried.

Discuss and Consider Date, Time and Location for the 2019-2020 Regular School Board Meetings

Dr. Green made a motion to approve the Board meetings on the third Monday of each month with the exception of Tuesday, January 21, 2020 and Thursday, March 19, 2020 due to school holiday conflicts. Mr. Starks seconded the motion. The motion carried.

Consider Approval of Custodial Services Contract

Director of Finance John Walker presented the eighth addendum to the custodial service contract to ABA Texas General Services Inc. (formerly GCA Services) effective July 1, 2019

through June 30, 2020. During discussion, Mr. Walker explained that the firm was short-handed and finding it hard to find good people in the area. He said that efforts were being made with the parent company to address these issues. Mr. Starks made a motion to approve addendum to contract as presented. Ms. Herring seconded the motion. The motion carried unanimously.

Consider Resolution Approving Extension of Bank Depository Contract for 2019-2021 School Years

Mr. Alderman explained that the Board went out for bids for the bank depository contract in 2017 and Guaranty Bank & Trust was awarded the contract. He recommended that we extend that contract for another two years. Dr. Green made a motion to extend the bank depository contract for the 2019-2021 biennium to Guaranty Bank & Trust. Mr. Wittkopf seconded the motion. The motion carried unanimously.

Consider Approval of Tax Resale Deeds

Superintendent Charlie Alderman explained that three properties were in Neylandville and one was in the Norris community. Mr. Wittkopf made a motion to approve tax resale deeds and resolutions for properties R106624, R21894, R115739 and R52669 as presented. Dr. Green seconded the motion. The motion carried unanimously.

Informational Reports

Enrollment was 1544, up three students from this time last year—the highest this school year. Mr. Alderman invited Board members to participate in the graduation ceremony to be held at 8 p.m., Friday, May 24 at the Texas A&M University-Commerce Fieldhouse.

The principals presented their monthly reports.

The date for the June Board meeting will be Monday, June 17, 2019. The meeting will be held at 7 p.m. Executive session will be held at 6 p.m.
