# Board calls May 9 election, discusses property

In action during its regular February meeting on the 16th, the CISD Board approved calling a trustee election on May 9. Places 6 and 7, currently held by Randy Starks and Etta Herring, are up for election. Both incumbents have filed for office. Filing continues through February 17 at the CISD Administration Building.

The district conducts joint elections with the City of Commerce and the North Hunt Special Utilities District. If incumbents remain unchallenged, the district is allowed to cancel the election. If not, early voting will be held at City Hall from April 27 through May 5. Extended early hours voting will be held May 4 and 5 from 7 a.m. to 7 p.m. at City Hall.

The Board approved a resolution to declare March 9-13 as CISD Public Schools Week. Open houses are planned Monday and Tuesday with ACW and CHS on March 9 and CES and CMS on March 10. The Commerce Leadership Institute class will visit campuses on March 12.

The Board discussed the city's request that the district deed its interest in property located at 1520 Pecan Street. The property has already been taken off the tax rolls due to tax default. The city would like to provide more parking for events held at the city gym. Board members gave City representative Steve Wilson the go-ahead for the city to draw up a deed to be considered by the Board.
