Conduct Canvass of Votes and Certify the May 4, 2019 Trustee Election for 1, 2 and 3 Dr. Reid made a motion to certify the election and declare the results of the May 4, 2019, Commerce ISD Trustee Election office for Places 1, 2 and 3. Ms. Hooten and Dr. Green were unopposed and Gabe Wittkopf received 264 votes to Elva Resendez's 124. All incumbents were reelected. Mr. Starks seconded the motion. The motion carried unanimously.

Mr. Wittkopf made a motion to extend personnel contracts for Tri County SSA personnel as presented. Dr. Hendricks seconded the motion. The motion carried with five ayes and two abstentions—Dr. Reid and Dr. Green.
